



# MBARA GOLF CART RAFFLE RULES

1. **Eligibility:** The raffle is open to individuals who are 18 years of age or older at the time of entry. You do NOT need to enter the Kingfish Tournament to participate. MBARA Board of Directors is not eligible to participate.
2. **Entry Method:** Participants can enter the raffle through the MBARA website at [mbara.org/golf-cart-raffle/](http://mbara.org/golf-cart-raffle/). Each ticket constitutes one entry into the raffle.
3. **Tickets and Pricing :** There will be a limit of 100 raffle tickets with each ticket being \$100. A participant may obtain more than one ticket.
4. **Raffle Period:** Raffle tickets will be available online from 6 June 2024 through 11:59 PM CT on 24 July 2024. The raffle will close once the 100-ticket limit has been reached or by 24 July, whichever comes first.
5. **Drawing Date:** The drawing will be at the MBARA Kingfish Tournament Captains Party on 26 July 2024, between 6:00-8:00 PM CT. You do NOT have to be present to win.
6. **Prize Description:** Gulf Coast Custom Carts is donating a completely refurbished 2020 EZ-GO TXT golf cart: new body, top, lights, seats (front and back) windshield, wheels, tires, and Trojan batteries (48 volts. 8. **Delivery or Pickup:** Gulf Coast Custom Carts will deliver the cart to the winner if within 50 miles of Mexico Beach.
